NOTICE OF RACE

1.0 RULES

The regatta will be governed by *The Racing Rules of Sailing (RRS)*, the ISSA Procedural Rules, the PCISA Supplemental Rules, this Notice of Race (except as changed by the Sailing Instructions), and the Sailing Instructions.

2.0 ELIGIBILITY AND ENTRY

2.1 This regatta is open to all ISSA member schools.

2.2 Eligible teams may enter by completing the attached registration form.

2.3 All entries must be received by **Wednesday, March 24, 2010 at 1700 hours.**

3.0 FEES

Entry fee is \$30 per sailor, which includes breakfast, lunch and snacks after racing each day. This fee will be collected at check-in on Saturday morning.

5.0 SAILING INSTRUCTIONS

The Sailing Instructions will be available at check-in on Saturday morning. An unofficial copy of the Sailing Instructions may be found on the StFYC website prior to Saturday.

6.0 BOATS & ROTATION

There will be no rotation for this event. **All teams must bring 2 class legal CFJs** (one for A division and one for B division). Each boat must have either a unique sail number or name printed in large letters on the mainsail.

7.0 RACING AREA

The intended race area will be either the water between Fort Mason and the San Francisco Marina or in Blackaller Cove .75 miles East of the Golden Gate Bridge South Tower.

8.0 SCORING

The regatta will be scored as per ISSA Procedural Rules.

9.0 BOAT & TRAILER STORAGE

All yachts competing in the event may be stored free of charge at StFYC one night prior to the beginning of racing and one night after racing concludes. If you plan on leaving a trailer in the City parking lot, an overnight parking permit must be obtained from the StFYC Front Desk. Trailers without a city permit may be towed. All boats & trailers should be stored at the direction of the StFYC Dock Master.

10.0 DISCLAIMER OF LIABILITY

Competitors shall participate in the regatta entirely at their own risk (see RRS 4, DECISION TO RACE). The organizing authority does not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during, or after the regatta.
