### NOTICE OF RACE

#### 1. RULES

The regatta will be governed by The Racing Rules of Sailing (RRS), the ISSA Procedural Rules, the PCISA Supplemental Rules, and the current NorCal Provisions.

#### 2. ELIGIBILITY, ENTRY & ENTRY FEE

- 2.1. This regatta is open to ISSA member schools.
- 2.2. Only teams that have participated in at least 6 of the 10 NorCal regular season regattas are eligible to compete.
- 2.3. Eligible teams may enter by completing the online registration form at [www.stfyc.com](http://www.stfyc.com).
- 2.4. All entries must be received by **Friday, March 14, 2014 at 1700 hours**.
- 2.5. Entry fee is \$40 per sailor, which includes lunch and snacks after racing each day. This fee will be collected at check-in on Saturday morning.
- 2.6. All teams shall submit the attached release form by the end of Check-In on Saturday, March 22.

#### 4. SAILING INSTRUCTIONS

The Sailing Instructions will be available at check-in on Saturday morning. An unofficial copy of the Sailing Instructions may be found on the StFYC website prior to Saturday.

#### 5. RACING AREA

The intended racing area will be either the water between Fort Mason and the San Francisco Marina or the City Front.

#### 6. BOAT & TRAILER STORAGE

All yachts competing in the event may be stored free of charge at StFYC one night prior to the beginning of racing and one night after racing concludes. If you plan on leaving a trailer in the City parking lot, an overnight parking permit may need to be obtained from the StFYC Race Office. Trailers without a city permit may be towed. All boats & trailers should be stored at the direction of the StFYC Dock Master.

#### 7. DISCLAIMER OF LIABILITY

Competitors shall participate in the regatta entirely at their own risk (see RRS 4, DECISION TO RACE). The organizing authority does not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during, or after the regatta.
