### Notice of Race

1. **ORGANIZING AUTHORITY**

The Organizing Authority (OA) will be each of the three clubs with events in the series.

2. **SCHEDULE**

The California Dreamin' Series (CDS) will consist of three match racing events: the San Diego Yacht Club Stop on January 9-10, 2016 in J/22 type boats, the Long Beach Yacht Club Stop on February 27-28, 2016 in Catalina 37 type boats, and the St. Francis Yacht Club Stop on March 12-13, 2016 in J/22 type boats.

3. **RULES**

The Notices of Race and Sailing Instructions of each event shall apply.

4. **ELIGIBILITY AND ENTRY**

Any skipper entered in at least one of the three events is automatically entered in the CDS. There is no entry fee for the CDS. Skippers who enter all 3 stops shall be given first priority for entry acceptance at each stop.

5. **SCORING**

5.1 Skippers shall receive points based on their finish in each of the three (3) events in the CDS. If a skipper does not enter an event, they shall receive zero (0) points for that event. Event points shall be applied based on the schedule below. The highest total of event points shall be declared the winner of the CDS.

5.2 **SERIES TIES**

RRS A8.1 and A8.2 shall apply to any CDS series ties. **RRS A8.1 and A8.2 shall be amended as follows: the word "Race" shall be replaced with "Event". The word "Boat shall be replaced with "Skipper".**

6. **PRIZES**

The principal prize for the winner of the CDS will be an invitation to the 2016 Ficker Cup to be held April 1-3, 2016.
